

The Chairperson of the Academic Council, Dr. C. Natarajan, Welcomed the members of the Academic Council. The following items on the agenda were prescribed for consideration and approval.

1. Introduction of members:

At the outset the Chairperson, Academic Council, introduced the members to the Academic Council.

2. Introduction about the Institute:

The Chairperson gave a brief introduction about the institute and its achievements towards academic curricular and co-curricular activities since its inception to the council members.



All the members appreciated the initiatives taken by the college for overall development and the measures for offering quality education.

3. Presentation of UG and PG Regulations 2020:

The Chairperson presented the UG and PG Regulations 2020 for the B.E. / B.Tech and M.E. / M.B.A degree programmes to be followed from the Academic year 2020 -2021.

4. Discussion about the Regulations 2020 and Curriculum of the Departments:

1. Dr. P. Kanagasabapathy suggested that the minimum grade for awarding first class degree for UG and PG programme to be fixed as 6.5 CGPA for both UG and PG programme. It has been decided to fix 6.5 GCPA all the UG and PG programme for awarding a first class degree.

2. Dr. P. Kanagasabapathy insisted that the M.E candidate who fails to clear project phase I shall be asked to repeat the same in the next semester. Further, the candidate is allowed to register for Project Phase II after clearing Project Phase I. It has been accepted and ratified in the PG Regulations 2020.

3. Dr. P. Kanagasabapathy suggested increasing the minimum eligibility marks of UG candidate required for the registration of Fast track courses from 7.5 CGPA to 8.0 CGPA.

After the discussion among the Academic council members, it is decided to retain 7.5 GCPA as the minimum requirement of CGPA for fast track course registration, in the view of providing opportunity to more students to do their project work in the industry which will enable them as an employability ready candidate once he complete his UG programme.

4. Dr. M. Rajalakshmi, enquired about the possibility to get internship for all the students during their course of study as internship is compulsory.

Internship programme was made compulsory to all the students of UG programmes, which will enable them to understand the industry in real time. Hence, it is decided to retain the same as stated in the Regulations 2020.

5. Dr. S. Sudha enquired about the evaluation Methodology followed for online courses.

As per the Regulations 2020, the candidate can undergo online courses which are approved by the respective board of studies of the departments and the end semester examination will be conducted by Controller of Examinations only which will be graded.

6. Dr. S. Sudha advised to rearrange the statement of fast track courses stated in page no 3 of UG Regulations 2020.



The statement was rearranged as mentioned **“The students shall undergo the eighth semester elective courses in sixth and seventh semester provided they shall have 7.5 CGPA with no standing backlogs”**.

5. Dr. Balaji Narasimhan stated that the both UG and PG Regulations were framed in a flexible way and the student community will be benefitted in large.

6. All the members expressed their happiness about the framework of the UG and PG Regulations 2020.

7. The Curriculum of all the departments were displayed and discussed.

8. The academic council decided to follow the Regulations 2017 prescribed by Anna University for the students studying in Second, Third and Fourth year of UG programme and second year of PG Programme for their entire duration of study.

9. The Academic Council members approved to implement the UG and PG Regulations 2020 and the Curriculum and Syllabus for I to IV semesters of all the UG and PG Programmes.

This comes into effect for the students who get admitted in this institution from the academic year 2020 – 2021.

10. The first meeting of Academic Council members came to an end by 12.10 PM of 07.08.2020, and the Member Secretary Dr. V. Suresh Babu delivered the vote of thanks.
